In consideration of being allowed to enter into the play center and/or participate in any parties or programs at Jump Up For Fun, the undersigned, on his or her own behalf and on behalf of the minor identified below, acknowledges, appreciates and agrees that:

1. Inflatables can be hazardous and dangerous. Activities require strenuous exercise and various degrees of skill and expertise. I understand that these activities can result in serious injury to the person or child. I assume any and all risk and damage or injury while on the Jump Up For Fun premises.
2. I am aware of the risk, hazards and danger of personal injury, disability and/or death as a result of participation at Jump Up For Fun.
3. In consideration for the admission of my child, I hereby release, waive, and forever discharge and covenant not to sue Jump Up For Fun and its owners, agents, employees, officers, directors, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expenses including attorney's fees which are related to or arise out of or in any way connected to my child's participation or use of the facility.
4. By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against Jump Up For Fun, its owners, agents, employees, officers, directors and/or all other persons or entities acting on its behalf.
5. I acknowledge that my or my child's participation in activities at Jump Up For Fun is strictly voluntary. I hereby certify that I'm over 18 years of age, I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had an opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risks and waive and release all substantial rights that I may have and possess.

**BY SIGNING BELOW, I EXPRESSLY STATE THAT I FULLY RELEASE AND INDEMNIFY JUMP UP FOR FUN FOR ANY AND ALL SUITS FOR JUMP UP FOR FUN'S OWN NEGLIGENCE, EVEN THOUGH CAUSED IN WHOLE OR IN PART BY A PRE-EXISTING DEFECT, THE NEGLIGENCE (WHETHER SOLE, JOINT OR CONCURRENT), GROSS NEGLIGENCE, STRICT LIABILITY OR OTHER LEGAL FAULT OF JUMP UP FOR FUN, ITS OWNERS, AGENTS, EMPLOYEES, OFFICERS, DIRECTORS AND/OR ALL OTHER PERSONS OR ENTITIES ACTING ON ITS BEHALF.**
